**SUBJECT: EXPIRATION OF COUNCIL FILES – Quarter ending June 30, 2009**

On September 13, 2005, the Council approved a policy wherein all Council files pending before the City Council which have not been placed on a Council or Committee agenda for consideration for a period of two years or more, are deemed received and filed (CF 05-0553). This Council policy was intended to handle the large accumulation of obsolete and outdated Council files which may no longer be relevant. The City Clerk is responsible for administration of this process.

Four times a year, the City Clerk disseminates a report (attached) at the end of each quarter which lists all soon-to-expire Council files. The report includes information relative to: Council file number, subject matter, author(s), and Council District number(s). For additional details regarding any of these files, select the hyperlink to the Council file number for access to the Council File Management System (CFMS).

Please review the attached report carefully. If there is an objection to the expiration of a particular Council file, please contact the appropriate Council Committee Chair to discuss your concerns. If the Chair concurs, the Legislative Assistant staff will be instructed to schedule the file on a Committee agenda which will automatically extend the file expiration for an additional two-year period, per Council policy. However, if the expiration deadline passes and there is a subsequent need to resurrect a previously expired file, most matters may be reintroduced via a Council Motion.
