#### **Title**

Street Furniture Program

### **Subject**

Motion - The Board of Public Works is currently developing a comprehensive street furniture program, including newsracks, transit shelters, trash receptacles, kiosks and automated public toilets. A contractor has been working with City staff on this project, but the contract must be extended and additional funds are needed for the extension period, to allow for the completion of the development of this program concept, drafting a Request For Proposals and selection of a contractor for the comprehensive street furniture program. THEREFORE MOVE that the Council, subject to the approval of the Mayor, authorize the Controller to transfer \$140,000 from Fund 100 Department 62 (Bureau of Street Services) Revenue Source No. 4101 to Fund No. 100 Department 74 (Board of Public Works) Account No. 3040 (Contractual Services) for services in connection with the development of a comprehensive street furniture program, including a newsrack ordinance and development of a Request For Proposals for selection of a contractor for this program.

JC Decaux joint-ventured with Viacom Outdoor and was recently awarded the contract to operate the City of Los Angeles' Coordinated Street Furniture Program. This program includes the provision of up to 150 APTs in areas throughout the City, none of which have been installed to date. In view of the problems experienced in San Francisco, it would be prudent for the Bureau of Street Services and Viacom Decaux to report to the City Council on the lessons learned from the San Francisco experience and what safeguards have been instituted for the Los Angeles program to avoid similar problems.
