Motion - MOVE that the City Council instruct the General Services Department and the Bureau of Engineering, with the assistance of the Department of Building and Safety, the City Administrative Officer, and the Chief Legislative Analyst, to report to the Council in 30 days on steps required to ensure all newly built City facilities larger than 7,500 square feet, or buildings with major renovations as defined by the USGBC, are built to the Leadership in Energy and Environmental Design (LEED) Silver standard; and that an integral part of this report include an assessment of the life cycle benefits associated with the implementation of the LEED Silver standard for the City, utilizing sources such as the USGBC and other studies conducted by federal or state government entities, other cities, or academial; etc.
