Communication from the Los Angeles Planning Commission, dated September 17, 2007, relative to proposed ordinance amending Section 12.24 of the Los Angeles Municipal Code (LAMC) to include multi-family residences as an allowed use for reduced parking through the Further Authority of the Zoning Administrator when parking management alternatives are applied and to further allow Metro transit riders to utilize project parking for access to rail and bus stations within 750 of a project. This ordinance will also remove the maximum allowable parking reduction that can be requested under this provision - City Planning Case No. 2007-2216-CA.
