For the last three years, the City of Los Angeles applied for and was awarded GALE grants of \$100,000 each year to help curtail illegal activities relating to alcohol abuse, including the sale of alcohol to minors. In 1997, Operation ABC, which originally targeted Foothill Area (Valley Bureau) and 77th Street (South Bureau), expanded to provide technical assistance to Vice Units throughout the City. In 1998, the Program expanded further and was anchored in one Area in each of the four Bureaus, as well as providing City-wide training and assistance with Task Force operations to address disorderly liquor outlets. Innovative enforcement and training programs have allowed Operation Alcoholic Beverage Control (ABC) to reduce service to minors and inebriated patrons, to reduce crime associated with disorderly outlets, and to improve the quality of life in neighborhoods proximate to the City's problem establishments.

THEREFORE MOVE that the City Council, subject to the approval of the Mayor, approve the grant application for Operation Alcoholic Beverage Control (ABC) Los Angeles in the amount of \$100,000 for the period July 1, 1999 to June 30, 2000, and authorize the Chief of Police to execute forthwith the application on behalf of the City.
