THEREFORE MOVE that CLA, CAO & Planning Dept be instructed to begin process for review & annexation of Westwood Park & adjacent Little League fields (not to include the Federal Building property or Veterans Administration property); & FURTHER MOVE that, because of the potential problems created by jurisdictional confusion surrounding this property, Planning Dept & CAO be instructed to complete their reviews relative to proposed annexation within sixty days of adoption of this motion
