**Site**

Motion - On Friday, December 6, 2002, the Hermon Community will be conducting the Annual Tree Lighting Ceremony from 6:00 pm through 8:00 pm. The City has received a request to declare this function a Special Event. Approval of this request will mean that an estimated \$312 in fees and salary costs will be absorbed by the City. THEREFORE MOVE that this event be declared a Special Event and the involved City Departments be requested to waive all fees, costs, and requirements. FURTHER MOVE that the City temporarily allow a street closure on 5718 Monterey Road and 525 Wheeling Way from 4:00 pm through 9:00 pm. FURTHER MOVE that the Bureau of Street Services be directed to furnish the necessary traffic control devices. Traffic control devices will be provided with the understanding that the sponsoring organization will pick up and return them to the Bureau of Street Services. FURTHER MOVE that should unforeseen circumstances change the actual date of the Special Event, the aforementioned departmental instructions continue to apply.
