# Subject

Motion - On March 5, 2002, under Council File No. 01-1459, the City Council adopted new procedures for processing street vacations, which require the adoption of a Rule 16 motion to initiate street vacation proceedings. The Los Angeles Unified School District, owner of the property bounded by Loma Drive, Crown Hill Avenue, Union Place, and Beverly Boulevard; has submitted an application requesting to vacate Loma Drive from 2nd Street to 440' southwesterly of Beverly Boulevard and 2nd Street from Crown Hill Avenue go Loma Drive, located in Council District 13. Additionally, the adoption of the following recommendations does not constitute or imply approval of the vacation. THEREFORE MOVE that upon adoption of this Motion, street vacation proceedings be initiated pursuant to California Streets and Highways Code, Division 9, Part 3, Public Streets, Highways and Service Easements Vacation Law. FURTHER MOVE that the Bureau of Engineering be directed to investigate the feasibility of this vacation request. FURTHER MOVE that the Bureau of Engineering present its report regarding the feasibility of vacating the requested area to the Public Works Committee.
