- d. Amendments to the Highways and Freeways Map of the Transportation Element of the General Plan to reclassify streets as outlined in the November 13, 2003, Staff Report to the City Planning Commission and noted as Attachment II, the recommended Land Use Change Map and Matrix (Exhibits C and D).
- e. The retention of R4 residential densities allowed by the C1.5 zone and the removal of the [O] condition proposed for Subarea 400.
