Election Procedures / Board of Fire and Police Pensions Commissioners / Revision Los Angeles Administrative Codes

Subject

Communication from the Department of Fire and Police Pensions relative to proposed revisions to the election procedures in the Los Angeles Administrative Code for the two elected retired Board members. The Board recommends the following major changes: 1. The ballot will be based on the "Notice of intent to Run" forms received in the City Clerk's office, eliminating the nominating election. 2. The candidate with a majority of votes will win the election. 3. A runoff election between the top two candidates will be held in the event no candidate received a majority of the vote. 4. A proposed new section would establish a deadline for and method of dealing with protests; the current Administrative Code language is silent on protests.
