## Subject

FURTHER MOVE that the Bureau of Street Services be directed to furnish the necessary traffic controls devices. These devices will be provided with the understanding that the sponsoring organization will pick up and return them to the Bureau. FURTHER MOVE that the Department of Transportation be directed to post "Temporary No Stopping" signs and provide traffic control personnel, as required. FURTHER MOVE that should unforeseen circumstances change the actual date of the Special Event, the aforementioned departmental instructions continue to apply.
