execute a Cooperation Agreement between the CRA and the DCP to share responsibilities, costs, and oversight in the development of a new South Los Angeles Community Plan (substantially as attached to the Chief Legislative Analyst (CLA) report dated March 13, 2007), subject to the review of the City Attorney as to form and legality.

2. AUTHORIZE the Chief Executive Officer, CRA, or designee, to negotiate and execute contracts in an amount not to exceed \$400,000 with pre-qualified consultants to perform the tasks necessary to create the South Los Angeles Community Plan, subject to the review of the City Attorney as to form

and legality.

- 3. AMEND the CRA's Fiscal Year (FY) 07 Budget to transfer \$400,000 from Work Objectives H09990 (Project General), H06990 (Response to Development Opportunities), and MC6990 (Response to Development Opportunities) to Work Objectives H06150 (Strategic Plan) and MC6150 (Strategic Plan) to fund consultant services for the preparation of an Environmental Impact Report, community outreach activities, and establishment of design guidelines for the South Los Angeles Community Plan. 5-2-07 Council Action Planning and Land Use Management Committee report ADOPTED to:
