SECOND AMENDMENT
TO AGREEMENT NUMBER C-122514 OF CITY OF LOS ANGELES CONTRACT
BETWEEN
THE CITY OF LOS ANGELES
AND
GOODWILL INDUSTRIES OF SOUTHERN CALIFORNIA

THIS SECOND AMENDMENT to Agreement Number C-122514 of City of Los Angeles Contract is made and entered into by and between the City of Los Angeles ("City") and Goodwill Industries of Southern California, a Corporation - Nonprofit Public Benefit ("Contractor").

RECITALS

WHEREAS, the City and Contractor have entered into an Agreement wherein Contractor shall provide certain services. Said Agreement was effective September 2, 2012, which together with all amendment(s) thereto shall hereinafter be referred to as the Agreement; and

WHEREAS, PSC-6, Exhibit A, Standard Provisions for City Contracts, provides for amendments to the Agreement; and

WHEREAS, the Agreement contemplates that modifications and closeout activities may be required after the time set forth in Section 201 of the Agreement; and

WHEREAS, on February 13, 2013, the South Bay Workforce Investment Board, Inc. (SBWIB, Inc.), a non-profit public benefit corporation, on behalf of the City of Inglewood, was awarded by the State of California, Employment Development Department (EDD) a 25% WIA Dislocated Worker Additional Assistance Project for the California Multi-Sector Workforce Partnership, which consists of fourteen (14) local workforce investment areas (LWIA); and,

WHEREAS, the City entered into a sub-grant agreement with the SBWIB, Inc., which serves as fiscal and administrative lead for the California Multi-Sector Workforce Partnership that is funded by the United States Department of Labor (USDOL) for re-employment services to dislocated workers for a grant term of nineteen (19) months retroactive to September 2, 2012 through March 1, 2014; and

WHEREAS, on February 12, 2014, the SBWIB, Inc. executed a unilateral first amendment of grant agreement 13-WO-62 to extend the grant term to June 30, 2014; and

WHEREAS, on April 22, 2014, the City and SBWIB, Inc. entered into a second amendment of grant agreement 13-WO-62 in extension of the grant term from June 30, 2014 to a new end date of March 31, 2015; and

WHEREAS, the City and Contractor are desirous of amending the Agreement as authorized by the City Council and the Mayor (refer to Council File Number 14-0805 dated June 26, 2014), and Section 14.8 of the Los Angeles Administrative Code which authorizes the General Manager of EWDD to prepare and execute an amendment to the Agreement for the purpose of:

- (a) adding an additional Nine (9) months for a new ending date of March 31, 2015;
- (b) updating standard contract language; and
- (c) making such other changes as are required in connection with the foregoing, all as detailed elsewhere in this Amendment; and

WHEREAS, this Amendment is necessary and proper to continue and/or complete certain activities authorized under the Agreement.

NOW, THEREFORE, the City and Contractor agree that the Agreement be amended effective July 1, 2014 as follows:

AMENDMENT

- §1. Amend Section 201, Time of Performance, by deleting the current ending date of June 30, 2014, and replacing with the new ending date of March 31, 2015. This amendment adds an additional Nine (9) months for a total term of Thirty-One (31) months.
- §2. Amend PSC-38, Subsection B of Exhibit A, First Source Hiring Ordinance, by changing all references in this subsection from CDD to EWDD.
- §3. Amend Exhibit A, Standard Provisions for City Contracts, by adding a new PSC-40, Iran Contracting Act of 2010 as follow:

PSC – 40. IRAN CONTRACTING ACT OF 2010

In accordance with California Public Contract Code Sections 2200-2208, all bidders submitting proposals for, entering into, or renewing contracts with the City of Los Angeles for goods and services estimated at \$1,000,000 or more are required to complete, sign, and submit the "Iran Contracting Act of 2010 Compliance Affidavit."

- §4. Amend Exhibit I, Scope of Work and Contractor Responsibility, by deleting its Subsection 4 of Section B, Program Responsibilities, in its entirety and replacing with the following:
 - 4. Contractor is required to close-out funds appropriated within ten (10) days following the date of March 31, 2015.
- §5. Amend Exhibit I, Scope of Work and Contractor Responsibility, by adding the following:

Contractor shall continue to provide the same services at the same level of service for the period of July 1, 2014, through March 31, 2015, as identified in the original Agreement and any amendments.
- §6. Except as herein amended, all terms and conditions of the Agreement shall remain in full force and effect.
- §7. This Amendment is executed in two (2) duplicate originals, each of which is deemed to be an original. This Amendment includes Three (3) pages which constitute the entire understanding and agreement of the parties.

IN WITNESS WHEREOF, the City of Los Angeles and Contractor have caused this Agreement to be executed by their duly authorized representatives.
