FIRST AMENDMENT
TO AGREEMENT NUMBER C-122514 OF CITY OF LOS ANGELES CONTRACT

THIS FIRST AMENDMENT to Agreement Number C-122514 of City of Los Angeles Contract is made and entered into by and between the City of Los Angeles ("City") and Goodwill Industries of Southern California ("Contractor").

RECITALS

WHEREAS, the City and Contractor have entered into an Agreement wherein Contractor shall provide certain services. Said Agreement was effective September 2, 2012, which together with all amendment(s) thereto shall hereinafter be referred to as the Agreement; and

WHEREAS, PSC-6, Exhibit A, Standard Provisions for City Contracts, provides for amendments to the Agreement; and

WHEREAS, the Agreement contemplates that modifications and closeout activities may be required after the time set forth in Section 201 of the Agreement; and

WHEREAS, the City Council, on August 21, 2013, adopted Council File Number 13-0948 and the accompanying Ordinance No. 182692 thereby abolishing the Community Development Department ("CDD"), amending the Los Angeles Administrative Code to re-designate the Economic Development Department as the Economic and Workforce Development Department ("EWDD"), and amending certain other provisions of the Los Angeles Administrative Code and Los Angeles Municipal Code to transfer specific administration of economic development functions from CDD to EWDD effective October 8, 2013; and

WHEREAS, the City and Contractor are desirous of amending the Agreement as authorized by the Section 14.8 of the Los Angeles Administrative Code which authorizes the General Manager of EWDD to prepare and execute an amendment to the Agreement for the purpose of:

- (a) changing the name of the City department administering this Agreement from CDD to EWDD;
- (b) adding an additional Four (4) months for a new ending date of June 30, 2014; and
- (c) making such other changes as are required in connection with the foregoing, all as detailed elsewhere in this Amendment; and

WHEREAS, this Amendment is necessary and proper to continue and/or complete certain activities authorized under the Agreement.

NOW, THEREFORE, the City and Contractor agree that the Agreement be amended effective March 1, 2014 as follows:

AMENDMENT

- §1. Amend the name of City department administering this Agreement from the Community Development Department (CDD) to the Economic and Workforce Development Department (EWDD).
- §2. Amend Section 201 of the original Agreement, Time of Performance, by deleting the current ending date of February 28, 2014, and replacing with the new ending date of June 30, 2014. This amendment adds an additional Four (4) months to the Agreement for a total term of Twenty Two (22) months.
- §3. Amend Exhibit I of the original Agreement, Scope of Work and Contractor Responsibility, by:
- (a) deleting its Subsection 4 of Section A, Purpose, in its entirety, and re-numbering subsections accordingly in sequence.
 - (b) deleting its Subsection 4 of Section B, Program Responsibilities, in its entirety and replacing with the following:
 - 4. Contractor is required to close-out funds appropriated within ten (10) days following the date of June 30, 2014.
 - (c) adding the following:

Contractor shall continue to provide the same services at the same level of service for the period of March 1, 2014, through June 30, 2014, as identified in the original Agreement and any amendments.
- §4. Except as herein amended, all terms and conditions of the Agreement shall remain in full force and effect.
- §5. This Amendment is executed in two (2) duplicate originals, each of which is deemed to be an original. This Amendment includes Three (3) pages which constitute the entire understanding and agreement of the parties.

IN WITNESS WHEREOF, the City of Los Angeles and Contractor have caused this Agreement to be executed by their duly authorized representatives.
