**FIRST AMENDMENT
TO THE PROFESSIONAL SERVICES AGREEMENT NUMBER C-142675
BETWEEN THE CITY OF LOS ANGELES AND
TK/COMMUNICATIONS, LLC**

This FIRST AMENDMENT to Agreement Number C-142675 of City of Los Angeles is made and entered into by and between the City of Los Angeles, a municipal corporation, acting by and through the Office of the Mayor (hereinafter "City") and tk/Communications, LLC (hereinafter "Contractor"), with reference to the following:

RECITALS

WHEREAS, on February 21, 2023, the City and Contractor entered into Contract No. C-142675 for various communication services in support of the Mayor's Administration with a term of December 12, 2022 through March 11, 2023;

WHEREAS, the City and Contractor desire to execute a First Amendment to the Agreement for the purposes of extending the term of the contract by two months to May 11, 2023; and

NOW, THEREFORE, the City and Contractor agree that the Agreement be amended effective upon execution as follows:

Article C is amended to provide a total contract amount for all services rendered pursuant to the Agreement not to exceed seventy-five thousand dollars (\$75,000).

Article F is amended to extend the termination of the Agreement to May 11, 2023.

Except as herein amended, all terms and conditions of the Agreement shall remain in full force and effect.

In the event of any conflict or inconsistency between the body of this First Amendment and the original Agreement, attachments or exhibits to this Agreement, the order of precedence is as follows:

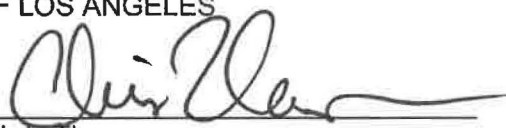
