BUDGET AND FINANCE COMMITTEE REPORT relative to settlement of case entitled Keiko Larez v. William Holcomb, et al., U.S. District Court Case No. CV 87-03641-CBM (Complaint relative to detention by police).

Recommendations for Council action, as recommended by the City Attorney, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. APPROPRIATE \$152,367.25 from the Liability Claims Account in the Unappropriated Balance to the City Attorney Liability Claims Account No. 9770.
2. AUTHORIZE the City Attorney to draw a demand thereon in said amount payable to Keiko Larez and Yagman and Yagman, her attorneys of record, to permit settlement of the above-entitled matter.

Analysis of corrective action: Confidential. If the Council wishes to consider this information, the City Attorney recommends that it do so in Closed Session pursuant to Govt. Code Section 54956.9(a).

SUBJECT FILE TO BE TRANSMITTED TO THE MAYOR FORTHWITH.

SUMMARY

The City Attorney reports that this action arises out of an incident on June 8, 1986, in which Police Detective William Holcomb began investigating a fatal gang-related shooting that occurred in East Los Angeles. Officers at the Hollenbeck Station informed Det. Holcomb that an eyewitness had provided information regarding the possible identity and location of the suspected gunman. This suspect was identified as Eddie Larez, brother of Keiko Larez, the plaintiff in this case.

Det. Holcomb dispatched undercover officers to observe the activities at and around the Larez home. Within an hour and a half, the officers observed a man, later identified to be Richard Jimenez who fit the description of the suspect, leave the Larez residence with Keiko Larez. The officers radioed Holcomb who was at the station, and were instructed to detain Keiko Larez and Richard Jimenez.

reports as follows:

Keiko Larez and Det. Holcomb have different accounts of the subsequent incidents. According to Larez, she was handcuffed and placed in a police car with Richard Jimenez; then held at the location until Det. Holcomb arrived, at which time she was questioned while handcuffed and then transported with Jimenez to the station in the same police car.

According to Det. Holcomb, Keiko Larez was briefly handcuffed and placed in a police car with Jimenez, then upon his arrival, removed from the car and briefly questioned while Jimenez was driven away by other officers. Keiko Larez then agreed to go to the station for questioning and was transported by Officers Martinez and Granados.

At the station, she was placed in a cell for questioning. According to Keiko Larez, she was in handcuffs. According to Det. Holcomb, she was not in handcuffs. Det. Holcomb states that he placed her in the cell so that she would not be seen by other persons during questioning.

She was released about half an hour later and driven to an area several blocks from her home and released. According to Det. Holcomb, this was done at her own request because she did not want to be seen with the police. According to Keiko Larez, this was done as an act of hostility.

Keiko Larez filed suit against Det. Holcomb, alleging that she had been seized in violation of her civil rights. A jury returned a verdict in favor of Keiko Larez, awarding her \$5,000 in compensatory and \$50,000 in punitive damages against Det. Holcomb. The court, in addition, awarded attorneys' fees in the amount of \$45,000 to Yagman and Yagman for the time spent on the case.

Det. Holcomb appealed, alleging, among other things, that the District Court had erred 1) in instructing the jury that the City would pay all compensatory damages, and 2) in allowing Mr. Yagman to argue that the City would also pay all punitive damages against Det. Holcomb.

On appeal, the defendants prevailed in its claim that the instruction and argument were erroneous. However, the U.S. Court of Appeals for the Ninth Circuit affirmed the verdict as to liability while remanding the case for a redetermination of damages and additional attorneys' fees for the past trial, the appeal, and any new trial.

A new trial date was set for August 1, 1994, with a final settlement conference scheduled for July 29, 1994. The attorneys for both sides have engaged in extensive settlement negotiations since the return of the appeal and the plaintiff is now willing to settle her case for \$152,367.25, inclusive of attorneys' fees. This settlement is also recommended by the District Court Judge, the Honorable Constance B. Marshall.


The City Attorney's Office recommends the proposed settlement. The Office has gained the advantage of a favorable ruling on appeal relative to the ruling of the District Court Judge and argument of the plaintiff's attorney that the City will pay punitive and compensatory damages for its employees.

This proposed settlement takes into account a realistic evaluation of the plaintiff's potential attorneys' fees even considering a minimal verdict from the new trial. A jury could award damages which when combined with the court's determination of attorneys' fees for two trials and an appeal could greatly exceed the proposed settlement.

At its meeting of 8-2-94, in Closed Session as permitted by Govt. Code Section 54956.9(a), your Committee concurred with the recommendations of the City Attorney and now submits the matter for Council consideration.
