
Business Improvement Districts (BIDS) have won accolades both nationally and locally for their ability to improve the quality of life for business communities. They provide service that makes the community cleaner and safer. These BIDS assess themselves to supplemental security services to work in concert with police divisions to develop coordinated solutions to neighborhood problems including illegal dumping, homeless issues, quality of life concerns, and other misdemeanor activity that is often considered a business nuisance.

Los Angeles Municipal Code Section 52.34 et. seq. presently provides that when Business Districts provide these additional services, whether through sb-contractors or their own labor force, they must secure a police permit and pay a fee for each officer to perform the BID service work..

I THEREFORE MOVE THAT Los Angeles Municipal Code Section 52.36 et. Seq. Be amended to provide an exemption for business Improvement Districts or their subcontractors as non-profit, self-help, community efforts to improve the quality of life in parts of the City of Los Angeles., and are not a private enterprise.
