Comments for Public Posting: My name is Cristina Cappy. I was homeless for more than 20 years most of my life transient product of the system my mother tried to kill me when I was 15 years old grew up in foster care been on the street most of my life. There are some issues that need to be addressed about the fact that Los Angeles county is giving vouchers to homeless people that are drug addicts they're doing fentanyl heroin and crystal meth I was given a voucher and approved an apartment through the Housing authority the inspection should have denied this apartment because there is a termite infestation in this complex for more than 10 years and with the earthquakes termites makes Department inhabitable according to the health department but yet the Housing authority approved this apartment that I'm in. The fact that Los Angeles county is giving vouchers to drug addicts I am living next door to someone that smokes fentanyl I had no heart problems and no health issues until I moved into this apartment and now I have a heart problem and I'm ingesting second hand fentanyl smoke and crystal meth smoke I reported it to the property and they're doing nothing. There is a second apartment on the second floor APARTMENT on the second floor that is also selling fentanyl crystal meth I am in a apartment that has drug sales and I'm ingesting drugs that are hurting my health and now I have to renew my voucher and I've only been here for 8 months and they want me to have a birth certificate and information I didn't need my birth certificate when I got my apartment and my voucher I have my social security card I have my Chase bank card I have my EBT card from the welfare office when I was getting EBT I don't understand why I'm going to lose my housing because of all these new laws rules about having to renew your voucher every year and requiring different information than was required when I got my voucher I do not have money on a \$1,200 a month budget to go to the DMV and pay for a new identification in the address that I'm in now when my identification card is not required to be renewed! My therapist with Edelman was supposed to be giving me therapy and asked to buy my belongings she asked to buy my TV I told her that I would never sell my stuff to her I couldn't believe she asked to buy my TV there were other instances with that same therapist that made me feel uncomfortable her denial of me being Italian her yelling at me all the time many different

instances I let Edelman go because of the unprofessionalism I have no one to represent me I'm going back out on the street in July because I don't have the money to get all the information and paperwork that this new renewal of my voucher is requiring you would think that LA county would put these drug addicts in halfway houses and give them the rehabilitation that they need but instead you're just handing every single homeless person a voucher patting them on top of the head and telling them to be good and shoving everybody who's homeless into an apartment without any type of rehabilitation without any type of access to mental rehabilitation physical rehabilitation you're just trying to put a Band-Aid on the homeless problem and not fix the root. I had an option to be able to move to another apartment but I have to pay for the deposit out of my own pocket the apartment complex Samo properties at 2029 Olympic boulevard Santa Monica California 90404 is renting apartments illegally with termite infestation oh did I mention the lack of hot water you have to run the the water for like 5 to 8 minutes before you even reach warm water which is according to the health department that came out and checked it illegal and water waste this complex is huge it has three buildings but yet nobody's doing any investigations on the illegal renting of apartments to section 8 vouchers this owner is taking advantage of people on section 8 taking advantage of the vouchers and taking advantage of the government's money and renting apartments that are inhabitable the lack of hot water and the termites as soon as there's an earthquake the building's going to topple down on top of me everybody in these complexes will be dead and the landlord will line his pockets from insurance this property has two different termite companies that treat these properties you would think that Los Angeles county I reported it to so many different places and it just falls on deaf ears so when I go homeless in July and go back out on the street after being raped more than 15 times my mom tried to kill me the government Los Angeles county everything is broken and if you keep giving homeless people apartments without giving them rehabilitation then you're doing nothing to help people you're doing nothing to help there should be an investigation on Edelman Sandra de stefanano my therapist that has to buy my TV she was completely unprofessional I wish I could get some help and not go homeless again in July I'm in apartment 120 call me 323-617-7317
