In addition to whom this may concern in the matter of civil and constitutional rights,

I AmKasharah Wainwright

I am demanding that Richard Solomon and Richard S Wolff of Venbrook Companies be held accountable to the fullest extent of the law including and not limited to those guilty by association and inaction for the Severe Harassment Psychological/ mental abuse, torment and 3 implications to threaten physical harm.

I am demanding for superior intervention immediately, that direct attention be brought to headline this story and the people who ought to be held accountable for violating both civil and constitutional rights of the U.S. Citizens and a Single Mother and a minor child specifically.

This is an epidemic and the afterbirth of a National Emergency that has brought this country to its knees in debt to the synthesis of poverty as the living consciousness of conditions caused by the circumstances of a broken system, and failure to enforce the law in a manner that forces the civilized conduct of those who believe they are superior to abide by the laws that govern our ecology of living as a productive society; as we collectively aim to unify as a people of dignity and respect.

Richard Solomon and Richard S Wolff have been served with a demand letter and continue to proceed with duplicitous strategies to force an illegal eviction without due process **after having isolated and caused conditions that would prohibit the peaceful enjoyment of our home. By failing to fix HVAC systems and Infestations for months, applying tactful rent increases with a new lease signed under duress; when the intimidation and harassment began in May 2022. Since then, we have been under 24/7 documented surveillance and become victims of their torment and harassment for a total of 9 months with documented proof of severe misconduct and negligent infliction of emotional distress and refusing to cooperate and adhere to several demands to stop the behavior.**

Richards' responses to the torment have been phrases like "you are unworthy of empathy" "your complaints are baseless & inflammatory and fruitless" "We will vigorously pursue an eviction" "you are the bully, you claim to be spiritual" denying and avoiding any fault or recognition to even so much as the reality that both my daughter and I have been forced to face for a prolonged period of time without any warrant for this type of conduct.

Which from a medical perspective causes severe neurological damage and debilitates the nervous system and breaks down the Maslows Hierarchy of needs in a theory of human motivation; devouring the self esteem that would empower self efficacy and ability self actualize.

These men have been able to dominate by applying forceful strategies to intimidate and force a self eviction by towing our vehicle, placing a lien on storage units, disconnecting utility resources, abusing their right to access the unit with unnecessary inspections, showing up to the property and outsourcing agents to serve more than (10) 3 day notices, posting them on mailboxes, bedroom doors and front doors simultaneously to cause humiliation and embarrassment as well as the infliction of emotional distress on an almost daily basis without relief.

These men have found pleasure and enjoyment in inflicting severe emotional distress upon an independent mother and disabled child who suffers from Severe Arnold Chiari Malformation and awaiting a serious brain surgery amidst watching her mother fight for her life, sanity and well being to stand up for the both of us.

This type of conduct threatens to force desolation by the prolonged process of a tactful, unjust and uncivilized infliction of emotional distress with negligence in order to forcefully cause an eviction status and then proceed with manipulation of Law to pursue an illegal eviction. Attention must be brought to the forefront and landlords must be held to a higher standard as we can examine from the Hollywood standoff involving the tenant in November 2022 who shot himself at the hands of landlords; who are like Richard Solomon and Richard S Wolff forcing conditions to cause illegal evictions and terrorize their victims into death by suicide in order to repossess a unit of property at the expense of a human life. These are not simply evictions flooding the court systems; these are "Crucifixions" that can be prevented with great attention to cases involving landlords who are willing to nail a tenant to a cross instead of preserving human beings with the very quality of their own life.

This is a severe violation of human rights and it can and must be stopped by the people who hold the seat and position of power.

If the goal is to eliminate unhoused citizens of this country then people like Richard Solomon and Richard S Wolff need to be held accountable and charged to the fullest extent of the law and held in contempt of the very bars of their victims of this type of

oppressive and abusive conduct.

We are demanding that the City of Los Angeles adheres to the Civil & Municipal Codes for the crimes to enforce the law to charge Richard Solomon and Richard S Wolff for the oppression including but not limited to the misdemeanor crimes committed; to the fullest extent of the law to ensure that this type conduct and behavior is severed immediately.

We will not yield until justice is properly served and penalties are due by the enforcement of the law that is secured in place to **establish justice and ensure domestic tranquility, to provide for the common defense, promote the general welfare and secure the blessings of liberty to ourselves and our posterity. As it is written in the United States Constitution.**
