This of course proves once again that you are not interested in helping AS MANY HOMELESS AS POSSIBLE.

You fiduciary duty is to work for and protect the local tax paying residents that are also paying your high salary; I assume you are getting full pay while we are all going bankrupt.

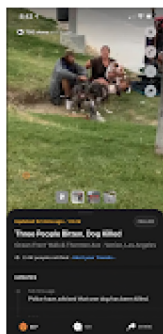

Thank you, Shandi, and I add my name to your concerns. I have long been very concerned and nervous about walking on the Boardwalk with aggressive dogs off leash. Our concerns sent to our Councilman have gone ignored and unanswered. Our concerns have been sent to LAPD, yet the dangerous conditions continue.

What happened this week was horrendous, and as a member of this community I am heartbroken for her.
