Hello,

I am just starting my campaign to make a change to some rules for Los Angeles Film Production which has been flooded with disruption due to a few individuals who insist that what they are doing is part of their first amendment rights. What they say is true "They have the legal right to film in a public place however, when it comes to harassment, aggravated assault, and an invasion of private information, what law protect us the victims from the incident continuing?

Can a restraining order be issued? and arrest with a fine? The answer has been "NO" from what we learned.

Zoe Perez, is an individual who claims he is an auditor of the constitution, yet he has appeared on a number of Police Reports and has made the news after being hit by bullet fragments fired from a Synagogues Security Guard. Zoe Perez, was fine to video record once through but then an hour later he continued, insulting and harassing the Production crew, including obstructing the sidewalk and creating a safety hazard. Our LAPD officer asked him to move on but Zoe Perez threw insults at the officer and refused to move. He then insulted one of the crew members which involved an altercation and disruption of the film production. Our LAPD officer then called 911 for LAPD assistance. They arrived but are now facing assault and battery charges against them as well as one of our crew members.

I plead with you to look into the case of **Zoe Perez**, and all his other encounters with city officials and personnel from his youtube channel, "Furry Potato". What he is doing is not exercising his 1st amendment, what he is doing is aggravated assault and harassment. Something must be done to help protect the people who work hard and pay taxes by these individuals who use the constitutional rights as a fake cover. We are trying to protect the LA Film Productions from leaving Los Angeles which I heard was down 15%? Please help me in my Campaign.
