Per the City Clerk, procedure states as follows, the Agenda, Agenda Items and the Board Reports to those items need to be sent to the City Clerk "together", not separately to be 48 -76 hours in advance to be posted and then heard at a Commission, Committee and or Council Meeting. This does not just apply to El Pueblo.

Action Items 1b and 1c cannot be heard, they are in violation of the Brown Act.

Also, I am asking for an Agenda Item to be addressed on Procedures for submitting Agendas and Board Reports to Commission, Committee and Council.
