



#### COUNCIL ADJOURNMENT

EXHAUSTION OF ADMINISTRATIVE REMEDIES - If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Clerk at or prior to, the public hearing. Any written correspondence delivered to the City Clerk before the City Council's final action on a matter will become a part of the administrative record.

COUNCIL RULE NO. 51 - Any member of Council may move to reconsider any vote on any question except to adjourn, suspend the Rules, or to reconsider, or where an intervening event has deprived the Council of jurisdiction, provided that said member had voted on the prevailing side of the question. The motion shall only be in order once during the legislative day in which the given question was voted upon, and once during the next regular meeting. If a motion to reconsider is first made at the next regular meeting after the question had been first voted upon, the member requesting reconsideration shall identify for all members present the Agenda number, Council file number and subject matter previously voted upon. A motion to reconsider is not debatable and shall require an affirmative vote of eight members of the Council. If a motion to reconsider is adopted, the subject matter shall be the next order of business after that which is before the Council at the time of the motion. This limitation shall not apply if the motion for reconsideration specifies a different time for further consideration of the subject and appropriate posting thereafter takes place where required by law.

COUNCIL RULE NO. 53 - If an Agenda item or other item has been duly placed before the Council at a Council meeting and the Council has failed by sufficient votes to approve or reject the item, or the Council has not by its vote placed the item beyond its jurisdiction at the meeting, or by operation of law, or by passage of time the Council has not lost the power to act thereon, the item is continued to the next regular meeting unless the Council affirmatively votes to continue the item beyond such next meeting. Each Council Agenda shall indicate that if the Council has not lost jurisdiction over an item voted upon at the meeting, or caused it to be continued beyond the



APPROPRIATION RE ATTORNEY CONTRACT

Honorable Members:



This letter requests that the Council determine (a) whether to amend Contract No. 95507 with the law firm of Christensen, Miller, Fink, Jacobs, Glaser, Weil & Shapiro, LLP, to provide for that firm's representation of members of the City Council and the Board of Police Commissioners in the lawsuits listed above; and (b) whether to appropriate the sum of \$300,000 or some other sum from the unappropriated balance to the City Attorney's Office, Department 12, Fund 100, Account No. 3040-Contracted Services. Those questions present policy issues for the determination of the Council and the Mayor.

We request that the matter be placed on the **closed session agenda** of the Budget and Finance Committee on **January 17, 2001**, and on the **closed session agenda** of the City Council on **January 24, 2001**.

The Christensen firm has represented members of the City Council, the Mayor, City attorneys, and the Board of Police Commissioners in the *Cunningham* and *Smith* litigation, which arose as the result of actions by the Police Department's Special Investigative Services ("SIS"). On September 15, 2000, the City received a favorable decision from the United States Court of Appeals for the Ninth Circuit in those cases. That decision dismissed the Council members, the "non-shooting officers", the City attorneys, and Captain Daniel Koenig from those lawsuits on the grounds of qualified

immunity. The dismissal of the Police Commissioners will take further motion work, which the Christensen firm has proposed to undertake.

The City's success in *Cunningham* and *Smith* has been costly. Attorney fees paid to the Christensen firm during the past five fiscal years for that litigation are noted below:

1995/96: \$53,389 1996/97: \$957,417 1997/98: \$848,709 1998/99: \$249,821 1999/00: \$105,387

The Christensen firm recommends its continued defense of the Police Commissioners in the ongoing *Cunningham* and *Smith* litigation, and its involvement in the other listed case, *W. Figueroa, C. Gonzales, et al. v. Gates et al.* The latter, more recent, case is related to SIS, and names individual Council members and Police Commissioners. The Christensen firm suggests that it would perform motion work in all of those cases during the remainder of the fiscal year for the sum of \$300,000.

The City Attorney's Office recognizes the contributions of the Christensen firm in the *Cunningham* and *Smith* cases. However, that the firm's continued involvement in SIS cases may not be cost effective in light of the capabilities of the City Attorney's Police Division. Although we expect that undertaking the defense of all of the City's official defendants would require readjustments within that division, our office believes that it can effectively manage that litigation without further assistance from the Christensen firm. However, some members of the Council have expressed the need for additional resources in SIS litigation involving City officials, and we submit that this is a policy decision for the Council and the Mayor.
