

An ordinance amending Ordinance No. 109262 establishing a building line.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 109,262; entitled "An Ordinance which in part established a building line on both sides of Osborne Street between Woodman Avenue and Foothill Boulevard in the City of Los Angeles" approved April 25, 1957, is hereby amended, by repealing the provisions establishing the building line on that portion of Osborne Street, as depicted on the following diagram:
