Fiscal Impact Statement: None submitted by the Los Angeles Police Department (LAPD). Neither the Chief Legislative Analyst nor the City Administrative Officer has completed a financial analysis of this report.


Summary:

In its report dated August 14, 2006, the LAPD transmits an application for a Graffiti Apprehension Reward Payment and the corresponding Investigation Worksheet for consideration and approval. The application was submitted after a defendant was arrested and convicted for graffiti vandalism of property in the City of Los Angeles. The claimant alerted the authorities after observing the defendant's actions at Jamie Beth Slavin Park in North Hollywood which resulted in the subsequent arrest and conviction.

At its meeting held August 14, 2006, the Public Safety Committee considered this matter and concurred with the recommendations of the LAPD, as submitted in its report dated August 2, 2006. This matter is now submitted to Council for its consideration.
