Both Hibbert and Patterson were shot in the head. Police believe that they may have been the victims of a robbery-related homicide. The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles. Unless withdrawn or paid by City Council action, this offer of reward shall terminate on, and have no effect after, FEBRUARY 15, 2016. 
