**RECOMMENDED ACTIONS**

1. That the Board of Police Commissions (Board) REVIEW and APPROVE the attached Application for Special Reward Payment.
2. That the Board TRANSMIT to the Mayor and City Council the Application for Special Reward Payment for review and approval.

**DISCUSSION**

In June of 2006, Los Angeles Police Department (LAPD) West Valley Area Sex Crimes Detectives were investigating allegations by multiple former patients of Eduardo Ramon Rodas Gaspar, a certified nursing assistant (CNA) at Tarzana Hospital. The patients described being sexually assaulted by Gaspar post-surgery, some while still under the influence of anesthesia. On June 15, 2006, Gaspar was arrested for three felony counts of sexual assault. The Los Angeles County District Attorney's Office charged Gaspar with multiple counts of sexual assault.

On July 7, 2006, LAPD West Valley Sex Crimes Detectives conducted a news release asking for the public's help in identifying additional victims. After the release, several additional victims came forth describing similar sexual assaults by Gaspar while they were patients at Tarzana Hospital. Upon learning the additional information, the Los Angeles County District Attorney's office filed seven additional felony counts against Gaspar, he skipped bail and disappeared with his wife and 6-year-old son.

After Gaspar's disappearance, LAPD West Valley Sex Crimes Detectives initiated an active manhunt for Gaspar. One of the initiatives was to hold a news conference, again asking for the public's help to find him. When that gave detectives no viable leads, detectives reached out to then Councilman Dennis Zine and asked for a monetary reward to anyone who provided police with a lead that would result in getting Gaspar back into custody. Initially, Zine's office offered

\$50,000. When that did not generate any good leads, the reward was increased to \$75,000. A few weeks after the news conference asking the public for information regarding Gaspar's whereabouts and announcing an increased reward, Detective Toosbuy of the LAPD West Valley Sex Crimes Unit received a phone call from Witness who explained she had information regarding Gaspar's whereabouts. Detective Toosbuy met Witness under the condition of ensuring her anonymity. During this meeting, Witness told Detective Toosbuy that Gaspar had fled to Guatemala, his country of birth. Specifically, he had returned to his hometown and was living with relatives. Witness knew this because Gaspar's adult daughter had been instructed by Gaspar to call him from Witness' home in order to avoid the risk of being "wiretapped" by police.

With this information from Witness, detectives were now able to confirm Gaspar's location in Guatemala with the help of the Federal Bureau of Investigation (FBI) which in turn enabled detectives in obtaining a foreign extradition warrant through the Los Angeles County District Attorney's Office. After the warrant was issued, Gaspar was arrested in Guatemala by local authorities who then turned Gaspar over to the FBI. Special agents of the FBI subsequently transported Gaspar back to the United States on June 26, 2017, and he was taken into LAPD custody. Gaspar was tried and convicted for the crimes he committed. On October 21, 2021, the Los Angeles City Council approved the motion to reinstate the reward for payment for the sexual assaults at Tarzana Hospital.

Without the tip/information provided by Witness, Gaspar would not have been located and subsequently prosecuted and convicted for his heinous crimes. The information provided was instrumental in the capture of Gaspar. Gaspar pled guilty on a plea bargain for five felony counts on June 9, 2019.

**SUBJECT:** PAYMENT ON REWARD OFFER FOR COUNCIL FILE NO. 08-0010

On February 3, 2009, a \$75,000 reward was offered by the Los Angeles City Council for information leading to the arrest and conviction of Ramon Eduardo Rodas Gaspar, the alleged perpetrator that sexually assaulted numerous patients, post surgery, some while still under the influence of anesthesia. Attached is a copy of the City Council Motion approving payment of the reward.

A community member came forward with information to Detective Toosbuy of the LAPD West Valley Sex Crimes Unit. Detective Toosbuy met with the citizen to verify the lead. The community member advised Toosbuy that Gaspar returned to his home country of Guatemala and was living with relatives. Detectives were able to confirm Gaspar's location in Guatemala with the assistance of the FBI. A foreign warrant was issued and local authorities arrested Gaspar in Guatemala. On June 26, 2017, Gaspar was taken into LAPD custody. He was tried and convicted for the crimes he committed.

The information received from the community member led to the arrest of Ramon Eduardo Rodas Gaspar. On August 20, 2019, Gaspar was sentenced to seven years in state prison and is a registered sex offender, Court Case No. LA052625, DR No. 0610-13138.

On April 8, 2006, a 29 year-old female patient reported to police that she had been sexually assaulted while under medical care at Tarzana Hospital. A West Valley Detective identified Ramon Eduardo Rodas Gaspar, 39, as the suspect. The investigation yielded two more victims who were both recovering from surgery in their hospital rooms when Gaspar allegedly assaulted them. After a warrant was issued, Gaspar surrendered to a judge on June 15, 2006 and was released on \$150,000 bail. Several additional victims have since come forward and contacted police regarding Gaspar. He has subsequently skipped bail and detectives believe he still poses a threat as a sexual predator.

The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles; therefore it is appropriate for the City of Los Angeles to offer a reward for information leading to the identification, apprehension and conviction of Ramon Eduardo Rodas Gaspar.

I THEREFORE MOVE that by adoption of this Motion, the City Council provide an offer of reward for information leading to the identification, apprehension, and conviction of Ramon Eduardo Rodas Gaspar, and in support thereof, make the following findings pursuant to Division 19, Chapter 12, Article 1 of the Los Angeles Administrative Code:

1. That Ramon Eduardo Rodas Gaspar is an at-large suspect in multiple sexual assault cases.
2. That this offer of reward is consistent with and taken for the immediate protection of the public peace, health and safety of local residents, as well as visitors to the City, and is consistent with the need to arrest and convict the person or persons who, because of not being apprehended, could by their actions further terrorize and present a continuing and immediate menace to the rights of persons in the City.
3. That the crimes committed by Ramon Eduardo Rodas Gaspar are especially disturbing and therefore, as a matter of public policy, the City hereby offers a reward as an added inducement for persons to come forward with information leading to the identification, apprehension and conviction of Ramon Eduardo Rodas Gaspar.
4. That the sum of \$50,000 shall be the aggregate maximum sum of any payment or payments of a City reward in this instance.
5. That the offer of reward shall be in effect for six months from the date of the advertisement of the reward by the City Clerk.

I FURTHER MOVE that the City Clerk be directed to cause notices and/or advertisements to be duly published according to the requirements of Division 19, Chapter 12, Article 1 of the Los Angeles Administrative Code, and to thereby cause the offer of reward to become effective.

# Ex-fugitive gets 7 years in prison for sexually abusing patients at a Tarzana hospital

VAN NUYS — A former nursing assistant who was a fugitive for more than a decade after being charged with [redacted] was sentenced Tuesday to seven years in state prison and ordered to register as a sex offender for life.

Ramon Eduardo Rodas Gaspar, 50, pleaded no contest June 7 to four felony counts of sexual battery by fraud and one felony count of sexual penetration of an unconscious person, according to Los Angeles County Deputy District Attorney Kelly Kraetsch.

The charges involved crimes committed against five female patients between February 2005 and April 2006, a spokeswoman for the District Attorney's Office said shortly after Gaspar's plea.



Former patients reported being sexually assaulted by Gaspar after undergoing surgery, some while still under the effects of anesthesia, according to the Los Angeles Police Department, which launched an investigation in June 2006.

Gaspar — who worked for two years at what was known at the time as Tarzana Hospital — failed to show up for a July 2006 court hearing, resulting in a bench warrant being issued for him nearly a month after a \$150,000 bond was posted on his behalf.

The case was featured on the Fox Broadcasting series "America's Most Wanted" and investigators learned Gaspar had fled to Guatemala, where he was arrested in February 2017. He was subsequently returned to Southern California, where he has remained jailed.
