Dear Councilman Huizar.

On May 11, 2009 The Eagle Rock Community Preservation and Revitalization board members met and reviewed a request by area Hotel and Motel owners to discuss the new ordinance put in place for low-incoming housing and residential status of the locations. Presenting the information was President of the North East Los Angeles Hotel Owners Association (NELAHOA), Ray Patel. After hearing the concerns, the ERCPR board is asking the City of Los Angeles and the appropriate branches of the City to sit with the NELAHOA and its representatives to review this ordinances, as we believe there are may unfair practices. We urge the City to go over its processes, the collection of surveys, the determination of residential status, the appeals process and all points of the ordinance that have severely impacted the owners of the independent hotels and motels targeted.

We also understand that attempts were made to secure a speaker from the Mayor's office and the Los Angeles Housing Department, and both declined.

This ordinance could have a long term negative effect on the businesses, the land and the over all value of the property if owners and their hotels are deemed to be residential hotels that require housing low-income residents and potential limiting of income revenue. It will also have a direct and immediate impact of the quality of life in certain residential areas that abut many of these locations. The ERCPR has worked very hard over the last decade to revitalize the business district in Eagle Rook. Our district is in close proximity to its residents, and having residential hotels with low income housing certainly will effect our revitalization efforts.

The ERCPR is asking that the Mayor's office file a report as to any and all meetings with the NELAHA and any action taken or proposed.
