The Department of Recreation and Parks, in conjunction with the Office of Councilmember Richard Alarcon and the San Fernando Valley Partnership, is sponsoring the "Hansen Dam Sprint Triathlon" on August 16th, 2009, from 7:00 A.M to 12:00 P.M. at the Hansen Dam Aquatic Center. The purpose of this event is to bring youth and adults from the community together with participants in the Junior Lifeguard programs to help promote both a healthy lifestyle and provide for a competitive sprit for all participants.

Councilmember Richard Alarcon from Council District Seven has received a request that the City provides certain services and declares this function a Special Event. Approval of this request will mean that an estimated \$2,822.00 in fees and salary costs will be absorbed by the City. (Event Coordinator: Gilbert Alvarez (818-899-2649).

I THEREFORE MOVE that the "Hansen Dam Sprint Triathlon" be declared a Special Event and that City departments be required to waive all fees and costs, including insurance. The event sponsors shall meet the application requirements of the City.

I FURTHER MOVE that pursuant to Ordinance No. 150,567 relating to temporary street closures, the following streets be closed on August 16th, 2009 from 5:00 A.M. to 12:00 P.M., subject to the supervision of the Director of Street Services:

- * Dronfield Street at the Entrance of Hansen Dam (All Traffic)
- * Foothill Boulevard between Osborne Street to Wentworth Street (One Lane)
- * Osborne Street between Glenoaks Boulevard and Foothill Blvd (One Lane)
- * Wentworth Street to Stonehurst (One Lane) (Actual Closures will end before Stonehurst since bicyclist will re-enter Hansen Dam Park via the Multi-purpose bike path along the Dam)

I FURTHER MOVE that the Bureau of Street Services be directed to deliver and later pick-up all necessary traffic control devices, barricades, road closed (signs), road closed ahead (signs), and flashers along the triathlon route.

I FURTHER MOVE that the Department of Transportation be directed to post "Temporary No Stopping" signs, and provide traffic control personnel, as required and necessary along the triathlon route as well as at all intersections.

I FURTHER MOVE that the Department of Street Services be directed to provide street sweeping along the triathlon route on August 15th, 2008 at 10:00 P.M and again on August 16th, 2008 between 3:00A.M and 5:00A.M. for the above-mentioned streets posted with "Temporary No Stopping"

I FURTHER MOVE that the Bureau of Sanitation be directed to provide refuse collection services.

I FURTHER MOVE that the Los Angeles Police Department be directed to provide personnel to assist with the security for this event, as necessary.

I FURTHER MOVE that the Los Angeles Fire Department be directed to provide emergency services for this event, if necessary.


I FURTHER MOVE that should unforeseen circumstances change the actual date of the Special Event, the aforementioned departmental instructions continue to apply.
