(e) Mr. Glushon moves, 2<sup>nd</sup> by Mr. Sarver, to amend text - “the valley’s miracle mile” on now on the sign be removed and color of Encino commons be changed from yellow gold to green. 13 pro, 3 opp, 4 abst. Passed.
