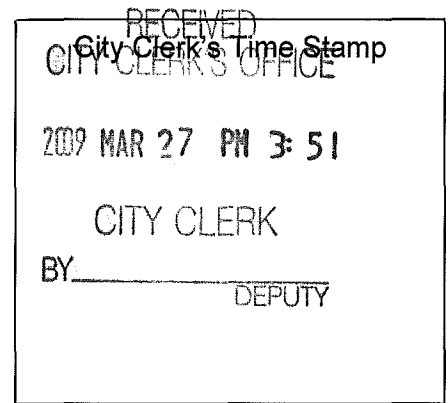
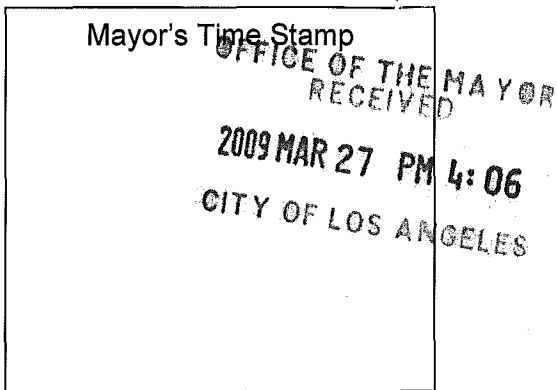

I HEREBY MOVE that Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Andrew Teague v. City of Los Angeles, Workers' Compensation Appeals Board Case No. Unassigned; Claim No. 9002-2002-2964. (Claimant alleges he sustained personal injuries during the course and scope of his employment as a Police Officer with the Los Angeles Police Department.), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. **AUTHORIZE the City Attorney to enter into a settlement in the case entitled Andrew Teague v. City of Los Angeles, Workers' Compensation Appeals Board Case No. Unassigned; Claim No. 9002-2002-2964, through a Stipulated Award at 100 percent total disability, estimated at \$807,634.20, payable at \$602.00 per week for the remainder of Applicant's life.**
2. **AUTHORIZE the City Attorney to execute the Stipulated Award with all appropriate parties for submission to the Workers' Compensation Appeals Board for its award of payment.**
