I HEREBY MOVE that Council APPROVE the following recommendations of the City Administrative Officer report (Item 2, Council file No. 09-0571) relative to the Proposition O (Prop O) Clean Water General Obligation Bond Program funding request for Albion Dairy Park Demolition and Remediation Project:

1. AUTHORIZE the Bureau of Engineering (BOE) to initiate planning, coordination, design, and implementation of the Albion Dairy Park Demolition and Remediation Project.
2. APPROVE the Prop O funding in the amount of \$3,956,400 as the Project Budget.
