 You are hereby notified that the Los Angeles City Council will hold a public hearing in-person on Tuesday, **December 5, 2023** at approximately **10:00 A.M.**, or soon thereafter, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (entrance on Main Street), relative to amending Sections 19.00 through 19.12 of the Los Angeles Municipal Code to establish three new planning and land use fees and align the adoption of fees with the Processes and Procedures Ordinances (Ordinance Nos. 187712 and 187930).
