MOTION

IMP Entertainment is sponsoring the "Pre IMP Party" on June 27, 2009, from 9:00 P.M. to 2:00 A.M.

Council District Thirteen has received a request that the City provide certain services and declare this function a Special Event. (Event Coordinator: Jimmy Paola - 310/562-2345 and Fax No.: 310/915-7218).

I THEREFORE MOVE that the "Pre IMP Party" be declared a Special Event, with the understanding that the event sponsor shall reimburse the City for all fees and costs associated with this event, and meet the insurance and application requirements of the City.

I FURTHER MOVE that the Event Sponsor be directed to fulfill the insurance requirements of the City by contacting the Bureau of Street Services - Investigation and Enforcement Division at 213/847-6000 to obtain, and complete, the necessary insurance forms, upon adoption of this Motion by the City Council.

I FURTHER MOVE that pursuant to Ordinance No. 150,567 relating to temporary street closures, the following streets be closed on June 27, 2009, from 6:00 P.M. to 3:00 A.M., subject to the supervision of the Director of the Bureau of Street Services:

- Sunset Boulevard between Ivar and Morningside (parking lane and sidewalk).

I FURTHER MOVE that the Bureau of Street Services be directed to furnish the necessary traffic control devices. These devices will be provided with the understanding that the sponsoring organization will pick up and return them to the Bureau, and remove any debris following this event.

I FURTHER MOVE that the Department of Transportation be directed to post "Temporary No Stopping" signs and provide traffic control personnel, if necessary.

I FURTHER MOVE that the City Council authorize the Chief Legislative Analyst, or his designee, to make technical corrections or clarifications as may be necessary to implement the intent of this Motion.

I FURTHER MOVE that should unforeseen circumstances change the actual date of the Special Event, the aforementioned departmental instructions shall continue to apply.
