Council District Four, the Community Redevelopment Agency, Los Angeles Department of Transportation, Department of Public Works, Bureau of Street Services, and the Los Angeles Police Commission are sponsoring the "NoHo Gateway Lighting Ceremony" on Thursday July 9th, 2009 at 7:00pm to 9:00pm. This is the official lighting ceremony of the NoHo Gateway on Lankershim Boulevard at Huston Street.

Council District Four has received a request that the City provide certain services and declare this function a Special Event. Approval of this request will mean that an estimated \$1,547 in fees and salary costs will be absorbed by the City. (Event Coordinator: Sandra Sunday 213/977-2614 Fax No. 213/ 617-8333)

I THEREFORE MOVE that the "NoHo Gateway Lighting Ceremony" be declared a Special Event, and city departments be requested to waive all fees and costs, including insurance. The lead City department responsible for this event shall meet the application requirements of the City.

I FURTHER MOVE that pursuant to Ordinance No. 150,567 relating to temporary street closures, the following streets be closed subject to the supervision of the Director of Bureau of Street Services:

Lankershim Boulevard from Huston Street to Camarillo
From Wednesday July 8th at 10:00pm to Thursday July 9th at 6:00am

Huston Street from Lankershim Boulevard to Bellflower Street
From Monday July 6th at 10:00am to Thursday July 9th at 10:00pm

I FURTHER MOVE that the Bureau of Street Services be directed to furnish the necessary traffic control devices. These devices will be provided with the understanding that the sponsoring organization will pick up and return them to the Bureau, and remove any debris following this event.

I FURTHER MOVE THAT that the Community Redevelopment Agency be directed to send out street closure notices to all businesses and residents no later than July 2, 2009.

I FURTHER MOVE that the Department of Transportation be directed to post "Temporary No Stopping" signs and provide traffic control personnel, if necessary.

I FURTHER MOVE that the City Council authorize the Chief Legislative Analyst, or his designee, to make technical corrections or clarifications as may be necessary to implement the intent of this Motion.

I FURTHER MOVE that should unforeseen circumstances change the actual date of the Special Event, the aforementioned departmental instructions shall continue to apply.
