I THEREFORE MOVE that the "34th Navasartian Games" be declared a Special Event, and City' departments be requested to waive all fees and costs, except insurance and application requirements.

I FURTHER MOVE that the Event Sponsor be directed to fulfill the insurance requirements of the City by contacting the Bureau of Street Services - Street Use Inspection Division at 213/847-6000 to obtain and complete the necessary insurance forms, upon adoption of this Motion by the City Council.

I FURTHER MOVE that the Bureau of Street Services be directed to furnish traffic control devices, if necessary. These devices will be provided with the understanding that the sponsoring organization will pick up and return them to the Bureau, and remove any debris following this event.

I FURTHER MOVE that the City Council authorize the Chief Legislative Analyst, or his designee, to make technical corrections or clarifications as may be necessary to implement the intent of this Motion.


I FURTHER MOVE that should unforeseen circumstances change the actual date of the Special Event, the aforementioned departmental instructions shall continue to apply.
