**A FISCAL YEAR 2010-11 DRAFT ORDINANCE AMENDING SECTION 89.60,  
CHAPTER VIII, DIVISION W OF THE LOS ANGELES MUNICIPAL CODE TO  
UPDATE THE CIVIL PARKING PENALTIES APPLICABLE TO PARKING  
VIOLATIONS IN THE CITY OF LOS ANGELES BY AN ADDITIONAL \$3 TO OFF-SET  
THE SURCHARGE IMPOSED BY THE STATE RESULTING FROM THE PASSAGE  
OF STATE SENATE BILL 857**

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your consideration the attached draft ordinance approved as to form and legality. The draft ordinance would amend in its entirety Section 89.60, Chapter VIII, Division W, of the Los Angeles Municipal Code (LAMC) to update the civil parking penalties applicable to parking violations in the City of Los Angeles. The draft ordinance will add an additional \$3 to all parking fines to off-set the \$3 parking surcharge imposed by the State of California resulting from the passage of State Senate Bill 857. The exact language of the bill is as follows:

*This bill would provide, commencing 60 days after the enactment of the Budget Act of 2010, and until July 1, 2013, that for each parking offense where a parking penalty, fine, or forfeiture is imposed, an added penalty of \$3 shall be included in*

*the total penalty, fine or forfeiture, as specified. This bill would require the county treasurer to transmit the penalty to the Treasurer for deposit in the Trial Court Trust Fund, as specified.*

An Ordinance amending Section 89.60, Chapter VIII, Division W of the Los Angeles Municipal Code in its entirety to increase fines and late penalty fees imposed for violation of any regulation governing the standing or parking of a vehicle under the California Vehicle Code or other State law, Federal law, and the provisions of the Los Angeles Municipal Code and the Los Angeles Administrative Code.

THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:

Section 1. Section 89.60, Chapter VIII, Division W of the Los Angeles Municipal Section is amended in its entirety to read as follows:

**SEC. 89.60. AUTHORITY.**

Pursuant to the authority of State law, a schedule of civil parking penalties is hereby established for the violation of any regulation governing the standing or parking of a vehicle under the California Vehicle Code or other State law, any Federal law, and provisions of the Los Angeles Municipal Code or of the Los Angeles Administrative Code. The following fines and late payment penalties are hereby established:

Any federal, state or local standing or parking regulation constituting a violation for which no provision is made in this schedule shall have a fine of \$58 and with late penalty of \$116 and a second late payment penalty of \$141.

The parking fines and late payment penalties listed here for a section shall apply to all unlisted subsections.

A parking fine shall be increased by a late payment penalty if payment is received more than 14 days from the mailing date of a notice of delinquent parking violation. For the purposes of this schedule, the penalties are added to the original fine and included under the "fine with late penalty" amounts listed above.

The second late payment penalty will be applied only if payment is received more than 58 days from the date of issuance. For purposes of this schedule, the second penalty is added to the fine with penalty amount.

Any surcharges or assessments, including any penalties or other fees, mandated by State law for a violation and not included in the fine and late penalties shall be added to the fine for the violation.

A parking fee shall be increased by the current DMV charge when a hold vehicle registration renewal is placed with the Department of Motor Vehicles.

A parking fine shall be increased by the amount of the fee that is charged to the City upon assignment as a delinquent account for Special Collection processing and/or if the City assigns to an outside collection agency or independent third party collectors.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
