

ORDINANCE NO. 180989

An Ordinance dedicating, accepting and establishing certain real property owned by the City of Los Angeles as part of Virgil Avenue east side, south of Oakwood Avenue, all public streets of said City.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:


Section 1. The City Council of the City of Los Angeles finds that the public interest, convenience and necessity require that an easement for public street purposes over the following described real property owned by the City be, and same is hereby dedicated, accepted and established as part of Virgil Avenue east side, south of Oakwood Avenue, all public streets of said City.

THOSE PORTIONS OF LOTS 11 AND 12 IN BLOCK B OF TRACT NO. 395, IN THE CITY OF LOS ANGELES, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP RECORDED IN BOOK 14 PAGE 178 OF MAPS, IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY, LYING WESTERLY OF A LINE PARALLEL WITH AND DISTANT 12.00 FEET EASTERLY MEASURED AT RIGHT ANGLES FROM THE EASTERLY LINE OF VIRGIL AVENUE 80 FEET WIDE AS SAID LINE WAS ESTABLISHED BY FINAL DECREE OF CONDEMNATION ENTERED IN CASE NO. 184,562 OF SUPERIOR COURT OF THE STATE OF CALIFORNIA FOR THE COUNTY OF LOS ANGELES, A CERTIFIED COPY OF SAID FINAL DECREE IS RECORDED IN BOOK 9345, PAGE 20 OF OFFICIAL RECORDS, IN THE OFFICE OF SAID COUNTY RECORDER.

EXCEPTING THEREFROM THOSE PORTIONS LYING WITHIN PUBLIC STREET.

Section 2. Pursuant to the provisions of Section 252 of the Charter of the City of Los Angeles, this ordinance shall become effective upon publication.
