 - a) **MOTION: The Board of the Studio City Neighborhood Council directs its President to create and send a letter to CD2 Councilmember Krekorian outlining current important issues Studio City considers priorities, substantially in the form attached hereto.**
13. Report Transportation Committee: Todd Royal (30 min).
 - a) **MOTION: The Board of the Studio City Neighborhood Council opposes the privatization of city parking assets. We support alternatives such as long term leases to private managers. The City should retain control over parking rate hikes and any other measures that could increase cost of parking to the public. Parking services should be regulated by the City in the interest of safety and accessibility. The City should terminate contracts with consultants who have been retained to engineer sale and/or lease of these projects.**

- b) **MOTION: The Board of the Studio City Neighborhood Council supports Council File Number 09-0002-S201, dated January 14, 2010, a resolution by Councilmen Garcetti & Cardenas to SUPPORT The Local Taxpayer, Public Safety, and Transportation Protection Act of 2010, a ballot initiative to amend the State Constitution that would prevent the State of California from seizing, diverting, shifting, borrowing, transferring, suspending or otherwise taking or interfering with tax revenues dedicated to funding local government services, including redevelopment funds or funds dedicated to transportation improvement projects and mass transit.**
- c) **MOTION: The Board of the Studio City Neighborhood Council supports a freeze on all capital expenditures and rail expansion projects until the Metropolitan Transportation Authority (MTA) can close a projected shortfall of operating funds of at least \$251.3 million by the end of the 2011 fiscal year.**

- b) **MOTION REGARDING CEQA APPEALS ORDINANCE: WHEREAS, The City of Los Angeles is in need of procedures for appealing CEQA determinations by non-elected bodies ("Procedures"); and WHEREAS, the Los Angeles City Attorney proposed a Draft Ordinance (the "Draft Ordinance") to establish Procedures which Draft Ordinance was set forth in a Los Angeles City Attorney Report Numbered R08-0423 and Dated November 10, 2008; and WHEREAS, the purpose of CEQA is to provide, among other things, for an opportunity for the public to have input on the consequences of governmental discretionary projects; and WHEREAS, the Draft Ordinance would limit public input and the rights of the public to seek review of CEQA determinations by non-elected bodies; and WHEREAS, THE STUDIO CITY NEIGHBORHOOD COUNCIL (i) has reviewed an alternate draft ordinance ("Alternate Draft Ordinance"), a true and correct copy of which is annexed hereto and made a part hereof, (ii) has discussed the Alternate Draft Ordinance and (iii) has concluded that the Alternate Draft Ordinance establishes appropriate Procedures; NOW, THEREFORE, BE IT RESOLVED that THE STUDIO CITY NEIGHBORHOOD COUNCIL does (i) hereby support the Alternate Draft Ordinance annexed hereto, (ii) hereby request that the Los Angeles City Attorney support the Alternate Draft Ordinance and (iii) hereby request that the Los Angeles City Council promptly adopt the Alternate Draft Ordinance.**
