The CIS process was enable by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Councils rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Summary: The United Neighborhoods of the Historic Arlington Heights, West Adams and Jefferson Park Communities Neighborhood Council (UNNC) has a longstanding embrace of historic preservation efforts within our footprint. CD10 Councilmember Heather Hutt has made a motion to expand the existing Jefferson Park HPOZ, noting that "A substantial segment of properties located on the south side of Adams Boulevard, specifically between 7th Avenue and Edgehill Drive, were excluded from the ordinance defining the HPOZ boundary. This exclusion is particularly significant given that these parcels are thoroughly documented in SurveyLA (published in 2012 and revised in July 2016) as integral contributors to

both the Adams Boulevard Courtyard Apartments Historic District and the Jefferson Park Historic Preservation Overlay Zone." But that's not all. The section of Adams Boulevard between Western and 7th Avenue (south side) is already included in the Jefferson Park HPOZ, while the north side of the street from Western to Crenshaw is included in the West Adams Terrace HPOZ (so this section between 7th and Edgehill is simply "orphaned" but otherwise dates from the same historic significance period). Plus: Earlier City-sponsored historic surveys also documented many of these same historic properties, and in addition this section of West Adams Boulevard (from Crenshaw Boulevard east to Figueroa) was also designated as a Cultural "Scenic Highway" in the City's Mobility Element. Yet the properties remain endangered and subject to varying interpretations by both LADBS and the Planning Department. For these reasons, and to help preserve the historic and architectural integrity of this section of Adams Boulevard, UNNC SUPPORTS the motion to expand the Jefferson Park HPOZ to include the south side of Adams Boulevard, once known as Los Angeles's historic "Street of Dreams."
