WHEREAS, Linda Lanier has provided the City of Los Angeles with more than 38 years of responsible and dedicated service to the People of the City of Angeles; and

WHEREAS, Linda Lanier began her City career in 1971 when she was hired as a Clerk Stenographer with the Model Cities Program. She later promoted to Senior Clerk Stenographer with the Commission on the Status of Women, and later transferred to the Community Development Department. In 1985, Linda promoted to Management Aide within the Personnel Department's Police and Fire Selection Division as an Examination Analyst. A year later, she promoted to Personnel Analyst I, and a year after that to Personnel Analyst II in the Equal Employment Opportunity/Employee Development Division. In 1993, Linda rotated into the Workers' Compensation Division as a Vocational Rehabilitation Analyst. That same year, she promoted to Senior Personnel Analyst I with the Los Angeles Police Department assigned as the Officer-in-Charge of the Civilian Training Unit. Linda reached her current classification as Senior Personnel Analyst II in 2001 and returned to the Personnel Department to manage the Employee Development Section; and

WHEREAS, the recipient of numerous Commendations and Certificates of Appreciation in her career; most notably, in 2004, Linda received the City Career Service Award in recognition of her outstanding contribution to City service. She successfully earned her Bachelor's in Public Administration from California State University, Dominguez Hills. She is also a graduate of University of Southern California's Technology Training Design and Development Program and the California State University of Long Beach's Leading Successful Organizational Change Program; and

WHEREAS, inspired by her faith, Linda is a 25-year member of Brookins Community African Methodist Episcopal Church in Los Angeles, where she has served on the Usher Board for over 20 years. Passionate about working with young people, she has been the Coordinator of the Brookins' Junior Usher Board for 15 years, and serves as an Advisor in the Young People's Department. The scripture that Ms. Lanier feels best exemplifies how she approaches her walk in life is Psalm 118:24 - "This is the day which the Lord has made, we will rejoice and be glad in it;" and

WHEREAS, for 12 years, Linda served on the Executive Board of the Los Angeles Association of Black Personnel, whose mission is to promote the interest of African Americans in the City of Los Angeles where she has held various offices, most recently as Third Vice President. She has also been involved in other professional organizations, such as the Oscar Joel Bryant Foundation, National Forum of Black Public Administrators and Southern California Personnel Management Association; and

WHEREAS, June Ulrich began her City of Los Angeles career on September 4, 1973 as a Messenger Clerk and then promoted to Library Clerical Assistant in the Library Department; and

WHEREAS, March 1980, June Ulrich was promoted to Senior Clerk in the City Treasury Department; and

WHEREAS, Between August 1980 and September 1989, June Ulrich promoted to Customer Service Representative and then to Management Aide at DWP; and

WHEREAS, September 1989, June Ulrich promoted to Management Assistant at the Department of Public Works; and

WHEREAS, April 1990 June Ulrich returned to DWP for a promotion to Management Analyst I; and

WHEREAS, December 1997 June Ulrich from transferred from DWP as a Management Analyst II to City Clerk; and

WHEREAS, June Ulrich began supervising in 1998 as a Management Analyst II managing the General City Purposes/Council Unit of the Fiscal Section, City Clerk's Office. Her unit was responsible for the daily fiscal administration of the General City Purposes and the City Council budget and preparation of the unit's own budget. She learned new tasks quickly, took additional responsibilities whenever staffing was short, and demonstrated superb interpersonal skills; and

WHEREAS, February 1999, June Ulrich received a Commendation for meeting extra work demands due to staff shortage, setting a good example as a supervisor, working during several weekends, and responding to questions from elected officials in a tactful and expeditious manner; and

WHEREAS, In 1999, 2002, 2003, and 2004, June Ulrich received the Outstanding Attendance Award; and

WHEREAS, June 2000, June Ulrich promoted as a Management Analyst II from City Clerk to Senior Management Analyst I at the Housing Department; and

WHEREAS, December 30, 2001, June Ulrich was promoted as Senior Management Analyst II to the newly created Office of Finance; and

WHEREAS, Since 2001, June Ulrich has been with the Office of Finance where she has performed her duties effectively. She improved customer service in the Call Center by increasing the answered calls up to 85%; and

WHEREAS, June Ulrich worked with LAPD to improve handling of permits and City Attorney's Office to implement the Tobacco Enforcement Program; and

WHEREAS, June Ulrich assisted in modifying the six-week business tax ordinance training into a three-week course and trained staff to verify on-line credit card payments; and

WHEREAS, June Ulrich has been an asset to the Office of Finance, Management Team during her nine years with the office. Her leadership, vision, dedication and service to the people of Los Angeles will be greatly missed by all who had the pleasure of working with her; and
