

ORDINANCE NO. 181853

An ordinance amending Section 22.239, Chapter 11, Article 5 of the Los Angeles Administrative Code to authorize the Board of Police Commissioners to set the fees for providing training to other law enforcement and public safety agencies to reflect the prevailing rates charged for providing such training services.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section. 1. Section 22.239 of the Los Angeles Administrative Code is amended to read as follows:


Sec. 22.239. Board to Establish Schedule of Fees.

The Board of Police Commissioners is hereby authorized, from time to time, to establish a schedule of fees for the various classes and sessions of the Police Training Program to be charged to persons other than members of the Los Angeles Police Department for attendance in said courses or sessions. The amount of the fees established pursuant to this section shall be based upon the prevailing rates charged in Southern California for providing such training services.


Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

DECLARATION OF POSTING ORDINANCE


