

**ORDINANCE NO. \_\_\_\_\_**

An ordinance amending Section 80.81 of the Los Angeles Municipal Code to change the speed limit on Alma Real Drive and on Corona del Mar in the City of Los Angeles.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Subdivision A of Subsection (1) of Section 80.81 of the Los Angeles Municipal Code is amended by deleting the following:

On Alma Real Drive between Altata Drive (north intersection) and Ocampo Drive (north intersection).

Sec. 2. Subdivision C of Subsection (1) of Section 80.81 is amended by deleting the following:

On Corona del Mar between Altata Drive (north intersection) and Chautauqua Boulevard.

Sec. 3. Subdivision A of Subsection (6) of Section 80.81 of the Los Angeles Municipal Code is amended by adding the following in alphabetical order:

Alma Real Drive between Altata Drive (north intersection) and La Cruz Drive.

Sec. 4. Subdivision C of Subsection (6) of Section 80.81 is amended by adding the following in alphabetical order:

Corona del Mar between Altata Drive (north intersection) and Chautauqua Boulevard.

Sec. 5. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


