COMMUNICATION FROM MEMBER, EDUCATION AND NEIGHBORHOODS COMMITTEE relative to an application to name a community Harbor Pines.

Recommendations for Council action:

- 1. APPROVE the application naming a community Harbor Pines, within the boundaries as detailed in the attached Bureau of Engineering map dated November 12, 2010. The naming will exclude properties located in the City of Lomita and unincorporated areas of Los Angeles County.
- 2. INSTRUCT all relevant departments to perform the necessary requirements to effectuate the naming of this community, including, but not limited to, the installation of signs.

<u>Fiscal Impact Statement</u>: Neither the Chief Legislative Analyst nor the City Administrative Officer have completed a financial analysis of this report.

Community Impact Statement: None Submitted.

SUMMARY

In the application submitted on April 10, 2010, the community boundaries were listed as "East of Western, South of Anaheim, North of PV Drive North". In a transmittal dated November 12, 2010, the Bureau of Engineering stated that the area described in the application is a part of the Wilmington-Harbor City Community Plan Area and the Harbor City Neighborhood Council District. They also stated that some of the properties named are in the City of Lomita, not inside of the City of Los Angeles.

At a special meeting held on December 15, 2010, the Education and Neighborhood Committee considered the application to name a community Harbor Pines. An opportunity for public comment was held. The Chief Legislative Analyst provided background information for the Committee. After a brief discussion, the Committee recommended Council approve the application with the amended boundaries.

This matter is now forwarded to the Council for its consideration.
