Dear Councilmembers:

In October 2011 our Board approved and filed a Community Impact Statement OPPOSING the above referenced renaming application. This action followed extensive outreach including door-to-door solicitation of input and committee meetings. A copy of the CIS is attached and can be found here. The official position of the North Hills West Neighborhood Council has not changed.

On July 24, 2012 Councilmember Englander appeared in person at a Special Meeting and responded to the Education & Neighborhoods Committee Chair's question about the NHWNC's opposition stating [audio at 00:42:00] "Yes that's been resolved." This statement is summarized in the attached E&N Report as "The Councilmember expressed his support for the naming application and also noted that the opposition from the North Hills West Neighborhood Council has been resolved." The opposition has not been discussed nor resolved; Councilmember Englander's statement is false.

The Community Impact Statement reveals the following unaddressed concerns of stakeholders who participated in public meetings:

- Any lasting effect on property values would be minimal and insignificant
- Issues on Woodley Hill are substantially similar to issues facing North Hills
- Woodley Hill is a desirable area, similar to the rest of Western North Hills
- A name change would make Woodley Hill a less desirable part of Northridge
- Confusion would result: Sepulveda? North Hills? Woodley Hill? Northridge?
- North Hills changed from Sepulveda to distinguish from East of the 405 Fwy
- Many stakeholders would then want to extend Northridge to the 405 Freeway
- A change would divide a community of interest presently sharing common goals
- Newly formed Senate & Assembly District boundaries follow present borderlines
- Mission Hills Panorama City North Hills Community Plan follows borders





SUMMARY

At a special meeting held on July 24, 2012, the Chair of the Education and Neighborhoods Committee considered an application to change the name of a neighborhood in the north central San Fernando Valley. The application proposes renaming the neighborhood to the existing adjacent community of Northridge. The boundaries of the neighborhood to be renamed are: Lassen Street to the north, Woodley Avenue to the east, Plummer Street to the south, and Balboa Boulevard to the west.

The Councilmember representing the 12th Council District in which the community to be renamed is located, addressed the Committee Chair relative to the renaming application and responded to related questions. The Councilmember expressed his support for the naming application and also noted that the opposition from the North Hills West Neighborhood Council has been resolved.

After providing an opportunity for public comment, the Committee Chair recommended that the Council approve the application. This matter is now forwarded to the Council for its consideration.

Daily News Editorial: Moves to change community names may result in the Valley in general gaining a greater sense of place

MAYBE you saw the news last week that a neighborhood in what used to be called Sepulveda, and now is called North Hills (but is known locally as Woodley Hill) wants to be called Northridge. This is one of those ways in which the more things change in the San Fernando Valley, the more they stay the same. In the past generation, more than half a dozen Valley communities have either re-named themselves or adopted the names of neighboring communities.

Three different parts of Van Nuys were chipped off to join Sherman Oaks and form Valley Glen and Lake Balboa. Parts of North Hollywood, Canoga Park and Northridge became, respectively, Valley Village, West Hills and Porter Ranch. The western half of Sepulveda renamed itself North Hills to try to disassociate from the eastern half, whereupon the eastern half renamed itself North Hills.

And now, about 1,300 people in a residential area bordered on the north and south by Lassen and Plummer streets and on the east and west by Woodley Avenue and Bull Creek Wash (just east of Hayvenhurst Avenue) have asked the City Council to change their addresses from North Hills to adjacent Northridge.

Eventually, maybe we'll realize the constant fussing over communities' names robs all communities' names of their value.

Which is ironic, since these name-change bids usually are thinly masked attempts to protect local property values by taking more prosperous-sounding names. That's the case with the current request:

Census data shows that compared to North Hills, the community of Northridge has higher incomes, more college degrees, more elbow room, more two-parent families and more white people.

Such name-changing communities should fear no disapproval from the Los Angeles Daily News (a newspaper that used to call itself the Van Nuys Call, the Van Nuys News, the Valley News and Green Sheet, and the Valley News).

Still, it is fair to ask why people concerned about their community's image don't skip the name-change campaigns and put the same effort into actually sprucing up the community?

One answer is that these aren't cities per se, with their own governments, well-known borders and heartfelt civic pride. These communities are all under the wing of the city of Los Angeles, and increasingly they're just disposable names.

They're also parts of the San Fernando Valley. Perhaps one result of all of this shape-shifting among the individual communities will be an increasing sense of place for the Valley in general.

Longtime residents of a half-mile by half-mile square may find it hard to know what to say when people ask where they're from. Sepulveda? North Hills? Woodley Hill? Northridge?

It's simpler to say you're from the Valley, with confidence the area's mountain borders are going to stay where they are for the foreseeable future.
