An ordinance amending Section 22.119 of the Los Angeles Administrative Code to add Council District 15, as defined by Los Angeles Ordinance No. 182168, to the list of Council Districts where a mural may be placed on a lot that is developed with only one single-family residential structure and accessory structures.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Subdivision (7) of Subsection (d) of Section 22.119 of Article 3 of Chapter VII, Division 22 of the Los Angeles Administrative Code is amended in its entirety to read as follows:

(7) No mural shall be placed on a lot that is improved with only one single-family residential structure and accessory structures. Notwithstanding the foregoing, a mural may be placed on a lot that is developed with only one single-family residential structure and accessory structures if the lot is located within the boundaries of Council Districts 1, 9, 14 or 15, as defined by Los Angeles Ordinance No. 182168. The mural regulations set forth in this Section 22.119 are permissive. Thus, murals are only allowed as authorized by this Section 22.119. Any murals that are not so authorized are prohibited.

Sec. 2. The City Clerk shall certify to the passage of this Ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
