To Los Angeles City Attorney;

I support the general Mural Motion council file 11-0923, However,

- 1. I will do support murals in residential zoning of R1, R2, R3 and R4 that would be visible to neighbors, pedestrians, and or traffic within 500 feet in visual site in a residential zone.
- 2. Furthermore, I do not support the pilot program in Boyle Heights due to the inability of our Councilmen to have open discussion for the community and transparency. He has presented motion at City Council stating that the community has approved it, when in fact he never had a public meeting with 72 hours advance notification for all of the community. To support this decision, he has refused to have a community forum in Boyle Heights since 2006.

In addition, we happen to have the highest undocumented individuals in the city, and 80% of the community are renters, placing residential homeowners of less than 20% at a disadvantage as the minority group. Residential homeowners also stand to loose property value with unwanted numbers of murals.

3. I recommend that if this is accepted by the City Attorney and Council vote, to consider to allow residential areas from R1 to R4 to opt in my signing a petition for the mural within 500 feet of their property that would be visible of the mural. I believe that living the issue to opt out is more of a liability for the city and open for law sued, with a signature of the property owners, the city would not have a liability as much.
