

- i. Up to \$84,938.92 from Fund 54M, Department 46, Account 46J299 to Fund 100, Department 46, Revenue Source Code 5346, for reimbursement of grant funded fringe benefits for the Mayor's Office.
- j. Up to \$40,099.18 from Fund 54M, Department 46, Account 46J112 to Fund 100, Department 12, Revenue Source Code 5301, to reimburse the City Attorney for direct salary costs.
- k. Cash from Fund 53V, Department 46 and Fund 54M, Department 46, to reimburse the General Fund on an as-needed basis, upon presentation of proper documentation from LAFD, Los Angeles Police Department (LAPD), Emergency Management Department (EMD), Information Technology Agency (ITA), and the City Attorney, subject to the approval of the Mayor's Office of Homeland Security and Public Safety approval.

2. AUTHORIZE the Mayor to prepare Controller instructions for any necessary technical adjustments consistent with this action, subject to the approval of the City Administrative Officer (CAO); and, REQUEST that the Controller implement the instructions.

Fiscal Impact Statement: The CAO reports that this action will not impact the General Fund. Approval of the above recommendations will allow for the continued expenditures of the Fiscal Year 2010 and 2011 UASI grants. These are actions are in compliance with City financial policies in that budgeted appropriations will be balanced against receipts expected from the continuation of the grants.

SUMMARY

In a report to the Mayor and Council dated February 7, 2013 (attached to the Council file), the CAO states that the Mayor requests authority to reappropriate funds for the UASI grant awards. Specifically, the Mayor requests authority to re-appropriate a total of \$2,896,452.53 in 2010 UASI grant award funds for LAPD, ITA, EMD, LAFD, the City Attorney, and the Mayor's Office. Funding in the amount of \$2,034,620.57 is provided for the LAPD, ITA, EMD, and LAFD to continue work on various UASI projects. Attachment 1 of the Mayor's report to Council dated January 7, 2013 (attached to the Council file), provides a list of the approved UASI projects for these departments. For 2011, the Mayor requests authority to re-appropriate a total of \$2,596,478 for the LAPD, LAFD, EMD, the City Attorney, and the Mayor's Office. Funding in the amount of \$2,480,472.82 is provided for the LAPD, LAFD, and EMD to continue work on various UASI projects, as detailed in Attachment 1 in the Mayor's report to Council. The CAO recommends approval of the Mayor's request.

At its meeting held February 8, 2013, the Public Safety Committee recommended that Council approve the above recommendations, as recommended by the CAO.
