### SUMMARY

The Mayor's Office of Homeland Security and Public Safety (Mayor's Office) requests authority to re-appropriate funds for the Urban Areas Security Initiative 2010 (UASI 10) and 2011 (UASI 11) grant awards from the United States Department of Homeland Security (DHS).

#### UASI 10

On July 19, 2011, the City Council accepted the UASI 10 award (C.F. 10-1166) in the amount of \$55,937,717 for a grant performance period of October 28, 2010 to April 30, 2013. Funding for the City of Los Angeles supports the Emergency Management Department (EMD), Information Technology Agency (ITA), Port of Los Angeles (POLA), Los Angeles Fire Department (LAFD), Los Angeles Police Department (LAPD), and the City Attorney's Office and the Mayor's Office for management and administration of the grant. No matching funds are required.

The Mayor's Office requests authority to re-appropriate a total of \$2,896,452.53 for the LAPD, ITA, EMD, LAFD, City Attorney's Office and Mayor's Office. Funding in the amount of \$2,034,620.57 is provided for the LAPD, ITA, EMD, and LAFD to continue work on various UASI projects. Attachment 1 in the Mayor's Transmittal dated January 7, 2013 provides a list of the approved UASI projects for these departments. The position authorities for the LAFD, ITA and EMD associated with the UASI 10 are provided in the 2012-13 Personnel Authority Resolution. The position authorities for the other departments are provided in the Departmental Personnel Ordinance (DPO). No additional position authorities are requested.

The federal grant guidelines allows up to five percent of the grant for management and administration. Funding in the amount of \$861,831.96 is provided for management and administration, which includes \$66,831.96 to reimburse the City Attorney's Office for direct salary costs for one Deputy City Attorney III, \$559,131.60 in Mayor's Office direct salary costs, and \$235,868.40 in related costs for the Mayor's Office.

### UASI 11

On June 6, 2012, the City Council accepted the UASI 11 award (C.F. 11-1256) in the amount of \$58,035,381 for a grant performance period of November 18, 2011 to April 30, 2014. Funding for the City of Los Angeles supports the Emergency Management Department (EMD), Los Angeles Fire Department (LAFD), General Services Department (GSD), Information Technology Agency (ITA), Los Angeles Police Department (LAPD), Port of Los Angeles (POLA), Los Angeles World Airports (LAWA) and the City Attorney's Office and the Mayor's Office for management and administration of the grant. No matching funds are required.

The Mayor's Office requests authority to re-appropriate a total of \$2,596,478 for the LAPD, LAFD, EMD, City Attorney and Mayor's Office. Funding the amount of \$2,480,472.82 is provided for the LAPD, LAFD, and EMD to continue work on various UASI projects. Attachment 1 in the Mayor's Transmittal dated January 7, 2013 provides a list of the approved UASI projects for these departments. The position authorities associated for the LAFD and EMD associated with the UASI 11 are provided in the 2012-13 Personnel Authority Resolution. The position authorities for the other departments are provided in the Departmental Personnel Ordinance (DPO). No additional position authorities are requested.

The federal grant guidelines allows up to five percent of the grant for management and administration. Funding in the amount of \$125,038.10 is provided for the City Attorney's Office and Mayor's Office, which includes \$40,099.18 to reimburse the City Attorney's Office for direct salary costs for one Deputy City Attorney III and \$84,938.92 in related costs for the Mayor's Office.

  4. Authorize the Mayor’s Office of Homeland Security and Public Safety to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and instruct the Controller to implement the instructions.

## **FISCAL IMPACT STATEMENT**

There is no General Fund impact as a result of these actions. Approval of the recommendations within this report will allow for the continued expenditures of the Fiscal Year 2010 Urban Areas Security Initiative (FY 10 UASI) and the Fiscal Year 2011 Urban Areas Security Initiative (FY 11 UASI) grants. These actions are in compliance with the City's Financial Policies in that budgeted appropriations will be balanced against receipts expected from the continuation of the grants.
