The City of Los Angeles offers a reward payable at the discretion of the City Council to one or more persons in the sum or sums up to an aggregate maximum total sum of \$50,000 for information leading to the identification and apprehension of the person or persons responsible for the death of ANDRES ORDONEZ, in the City of Los Angeles, on Sunday, November 4, 2012, at approximately 6:20 p.m., 25-year old Andres Ordonez was fatally shot, and another individual was wounded, when they attempted to stop an individual from spray painting a church they attended, located in the 3000 block of West Beverly Boulevard. Both victims approached the suspect, described as a Hispanic female, and attempted to stop her from vandalizing the church. During the exchange, a second suspect exited a stopped vehicle and opened fire, hitting both victims. Detectives are continuing to investigate the shooting but have not identified the suspects at this time. Detectives hope that a monetary reward compels members of the public to provide more information. The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles. Unless withdrawn or paid by City Council action, this offer of reward shall terminate on, and have no effect after, MARCH 2, 2015.

The provisions of payment and all other considerations shall be governed by Chapter 12 of Division 19 of the LAAC Code, as amended by Ordinance Nos. 158157 and 166666. This offer shall be given upon the condition that all claimants provide continued cooperation within the criminal justice system relative to this case and is not available to public officers or employees of the City, their families, persons in law enforcement or persons whose misconduct prompted this reward. 

**AVISO DE RECOMPENSA DE \$50,000**  
 La Ciudad de Los Angeles ofrece una recompensa pagadera a la discreción del Concejo de la Ciudad a una o más personas por la suma o hasta una cantidad en conjunto de \$50,000 por información que conduzca a la identificación y detención de la persona o personas responsables por la muerte de ANDRÉS ORDÓÑEZ, en la Ciudad de Los Angeles. El domingo 4 de noviembre de 2012, aproximadamente a las 6:20 p.m., Andrés Ordóñez de 25 años de edad fue fatalmente baleado, y otro individuo resultó herido, cuando intentaron detener a un individuo con pintura en aerosol en una iglesia a la que asistieron, ubicada en la cuadra 3000 de West Beverly Boulevard. Ambas víctimas se acercaron al sospechoso, describiendo como una mujer hispana, y trataron de detenerla de destruir la iglesia. Durante el intercambio, un segundo sospechoso salió de su vehículo y abrió fuego, alcanzando a ambas víctimas. Los detectives continúan investigando el tiroteo pero no han identificado a los sospechosos en este momento. Los detectives esperan que una recompensa monetaria obligue a los miembros del público a proporcionar más información. La persona o personas responsables de este delito representan una amenaza constante para la seguridad de los habitantes de Los Angeles. A menos que se retire o se pague la acción por medio del Concejo de la Ciudad, esta oferta de recompensa terminará, y no tendrá ningún efecto posterior al 2 DE MARZO DE 2015.
